LAND & WATER CONSERVATION FUND



- The Land and Water Conservation Fund Program (LWCF) is a competitive grant program which provides federal funds for acquisition or development of land for public outdoor recreational use.
- Eligible applicants include all local governmental entities with the legal responsibility for the provision of outdoor recreational sites and facilities for the use and benefit of the public.
- A 50/50 match is required. The maximum grant amount is \$200,000.



FLORIDA RECREATION DEVELOPMENT ASSISTANCE PROGRAM

- The Florida Recreation Development Assistance Program (FRDAP) is a competitive grant program that provides state funds for the acquisition or development of lands for public outdoor recreation.
- Eligible applicants include municipal and county governments and other legally constituted entities with the legal responsibility to provide public outdoor recreation.
- Projects of \$50,000 or less qualify for a 100% grant. A local match is required for grants greater than \$50,000. The maximum grant amount is \$200,000.





FLORIDA COMMUNITIES TRUST

- The Florida Communities Trust (FCT) administers two competitive grant programs, the <u>Park and Open Space Program</u> and <u>Stan Mayfield Working</u> <u>Waterfronts Program</u>. These programs provide **state funds** to local governments and nonprofit organizations for land acquisition.
- The Park and Open Space Program provides grants to local governments and non-profit environmental organizations for the acquisition of conservation lands, urban open spaces, parks and greenways.
- The Working Waterfronts Program provides grants to local governments and non-profit working waterfronts organizations for the acquisition of interests in land for the restoration and preservation of Working Waterfronts.
- The maximum grant amount is \$5,000,000






RECREATIONAL TRAILS PROGRAM




- The Recreational Trails Program (RTP) is a competitive program which provides grants for projects that provide, renovate or maintain recreational trails, trailhead and trailside facilities. The grant program provides **federal funds** for the development and maintenance of recreational trails and trail-related facilities for both non-motorized and motorized recreational trail uses.
- Eligible applicants include all local governmental entities, state agencies, federal agencies, recognized Indian tribal governments and certain nonprofit corporations, which have an agreement with a governmental agency to develop public lands.
- All applicants are required to provide matching funds. The maximum grant amount is determined by the RTP Advisory Committee.


